This is a two component, polyamide cured, high molecular weight epoxy coating. Designed as a high build, all purpose coating for new construction. It contains 40 % zinc phosphate pigments by weight. Can be used as primer, mid coat, finish coat or as single coat system in atmospheric environments. Suitable for properly prepared carbon steel, galvanised steel and shop primed steel substrates.

#### **Typical use**

Suitable for structural steel and piping to be exposed to corrosive environments. Recommended for offshore environments, refineries, power plants, bridges, buildings and mining equipment.
