Surface preparation

Apply the product on the area to be treated. Allow to work for 2-5 minutes. If necessary, scrub the areas with shells, barnacles and other foulings with a stiff brush. Rinse well with fresh water. Alternatively, clean well with fresh water and a sponge.

Pretreatment

Clean with recommended Jotun Yachting detergent. Refer to TDS, direction for use for the selected Jotun Yachting product.

Storage

The product must be stored in accordance with national regulations. Keep the containers in a dry, cool, well ventilated space and away from sources of heat and ignition. Containers must be kept tightly closed. Handle with care.
