Directions for use

Surface preparation

Textile Cleaner. Refer to TDS, direction for use for the selected Jotun Yachting product.

Pretreatment

Shake the can before use. For contaminated surfaces dilute the product with water at a ratio of 1:5. Clean the surface using a cloth or spray pump. For heavily contaminated surfaces, use undiluted product. Clean the surface using a cloth or spray pump. Allow to work 10-15 minutes. Lightly scrub the surface with a moisten sponge, brush or cloth. Rinse well with fresh water.

Finish coat

Textile Watershield. Refer to TDS, direction for use for the selected Jotun Yachting product.

Remarks

The product should be used on colour resistant textiles.

Storage

The product must be stored in accordance with national regulations. Keep the containers in a dry, cool, well ventilated space and away from sources of heat and ignition. Containers must be kept tightly closed. Handle with care.
